The lids and caps must be put in the recycling bin.</p>	<p><b>RECYCLING BIN</b></p> <ul style="list-style-type: none"> <li>Packaging</li> <li>Films</li> <li>Plastic</li> <li>Beverage cans</li> <li>Tetra Packs</li> <li>Toothpastetubes</li> <li>Aluminium</li> <li>Tin plate</li> <li>Canned food</li> </ul> <p>No glass or paper packaging or batteries or electrical appliances such as USB sticks or razors.</p>
